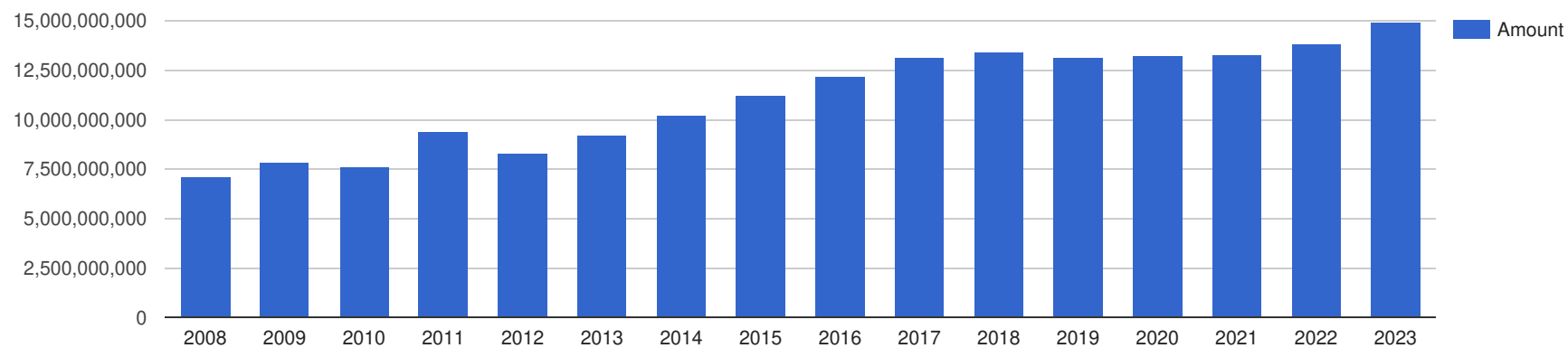

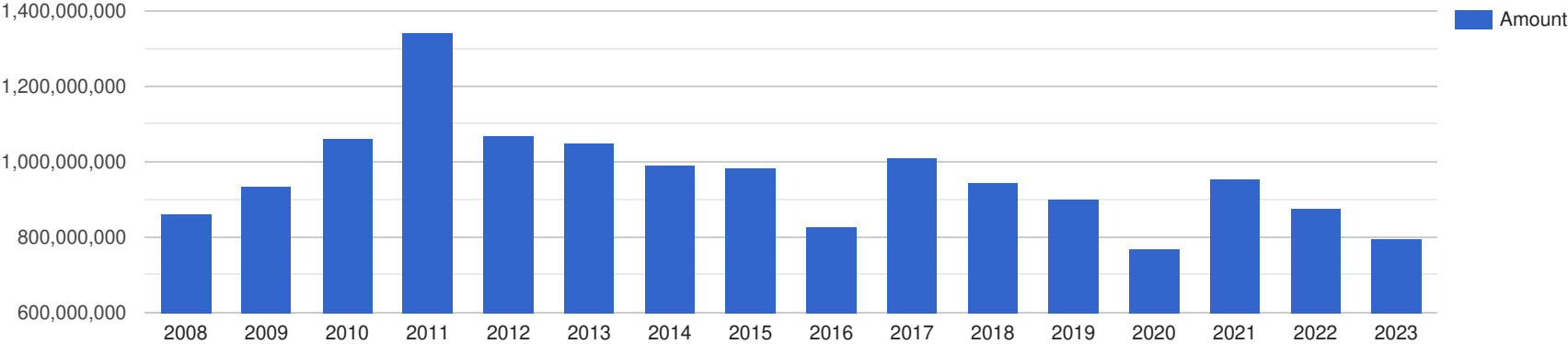

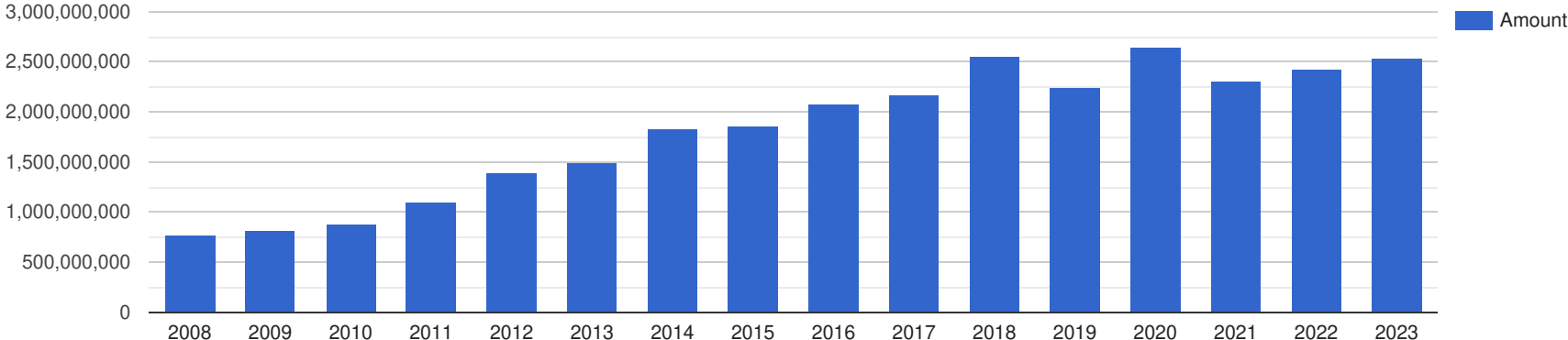
Company Revenue - ZAR



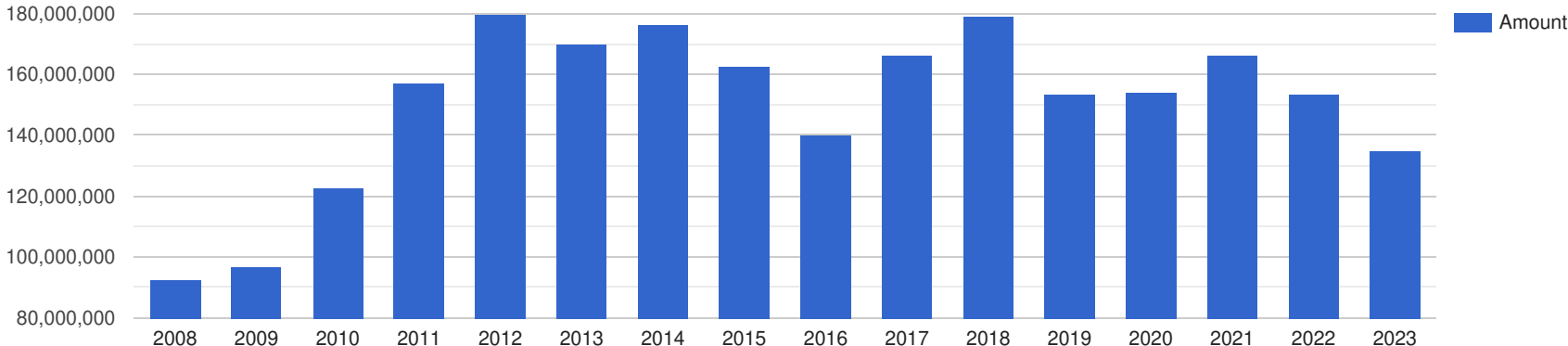
Company Revenue - USD

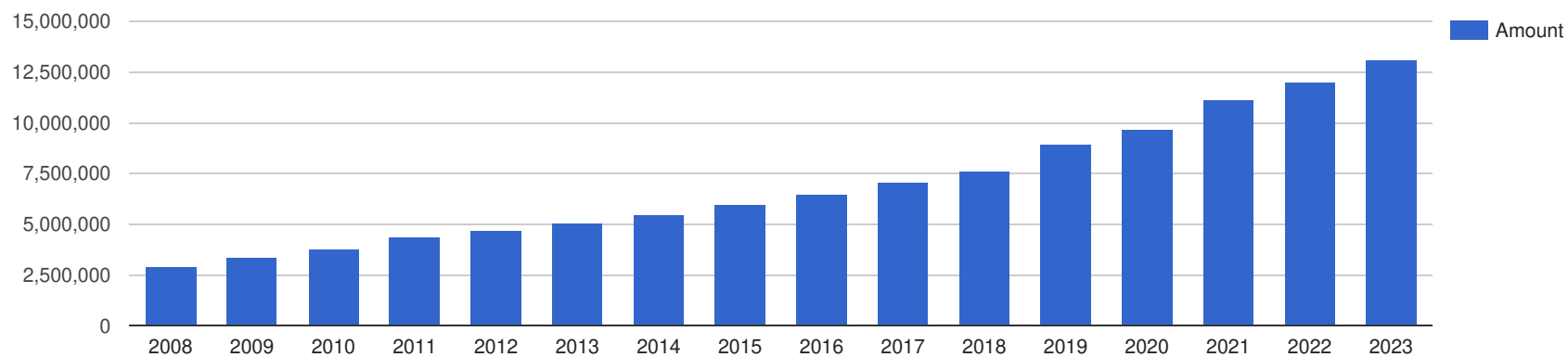

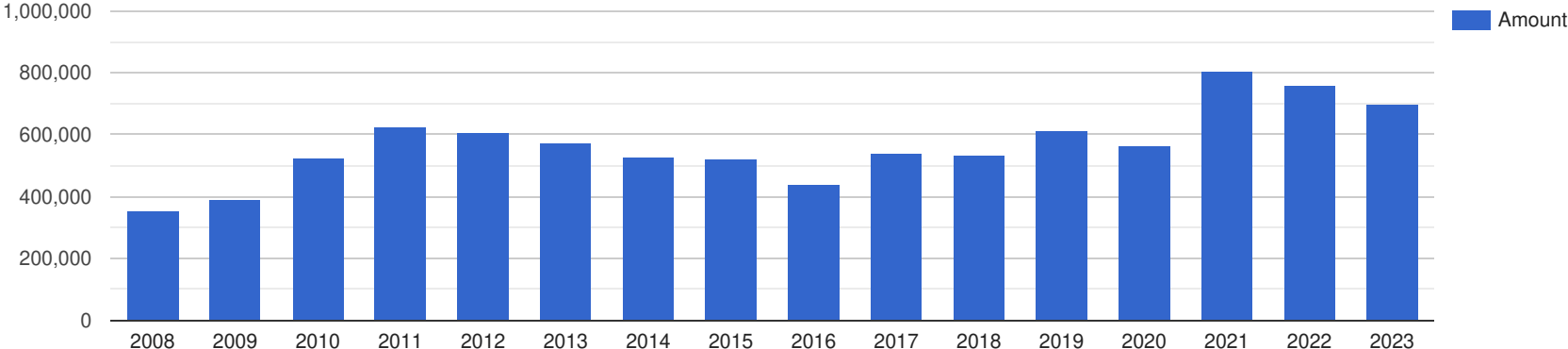

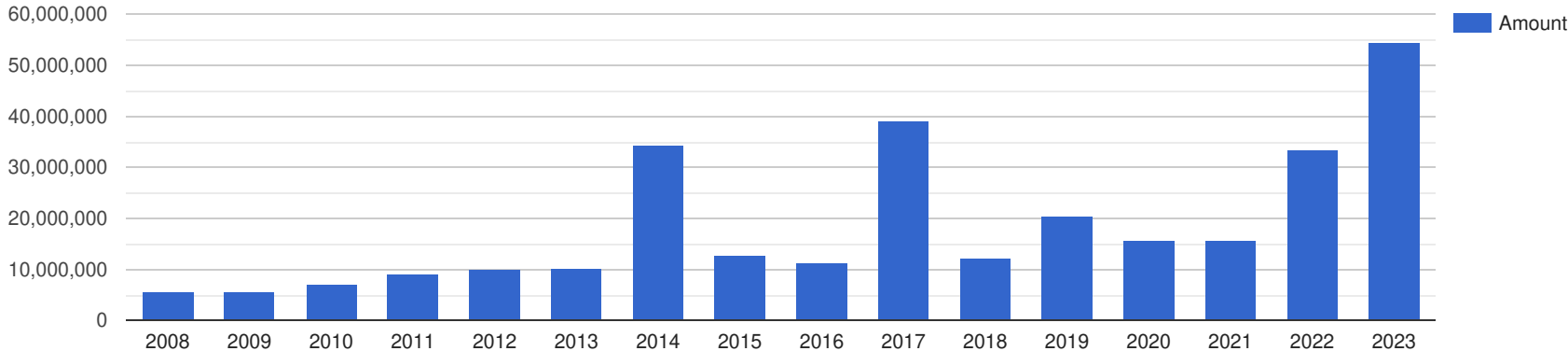
CEO Salary - ZAR



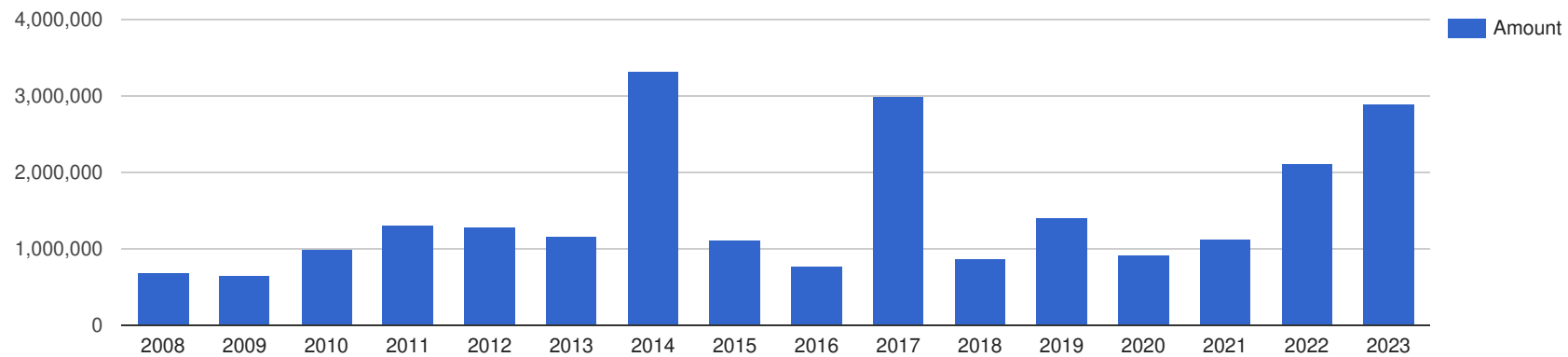
CEO Salary - USD



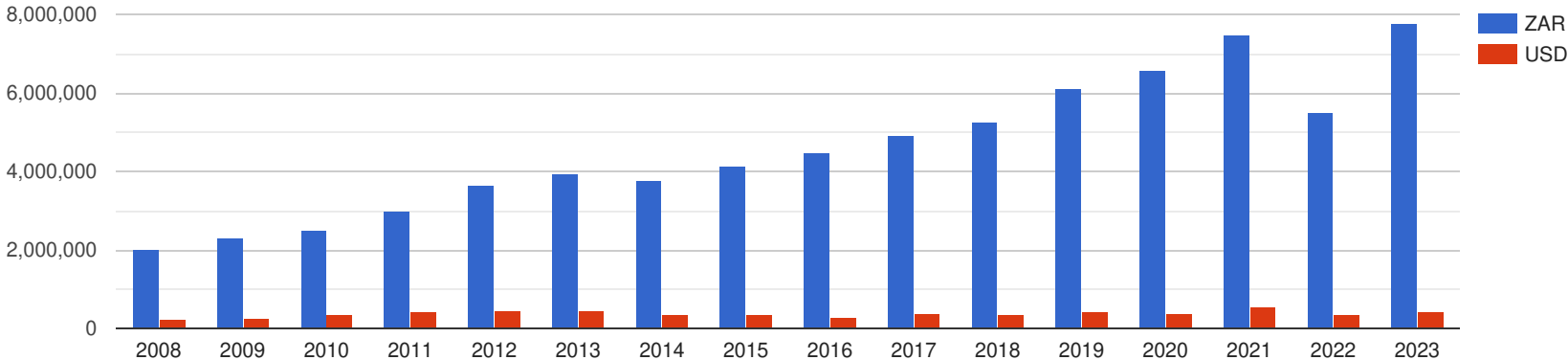
CEO Remuneration - ZAR



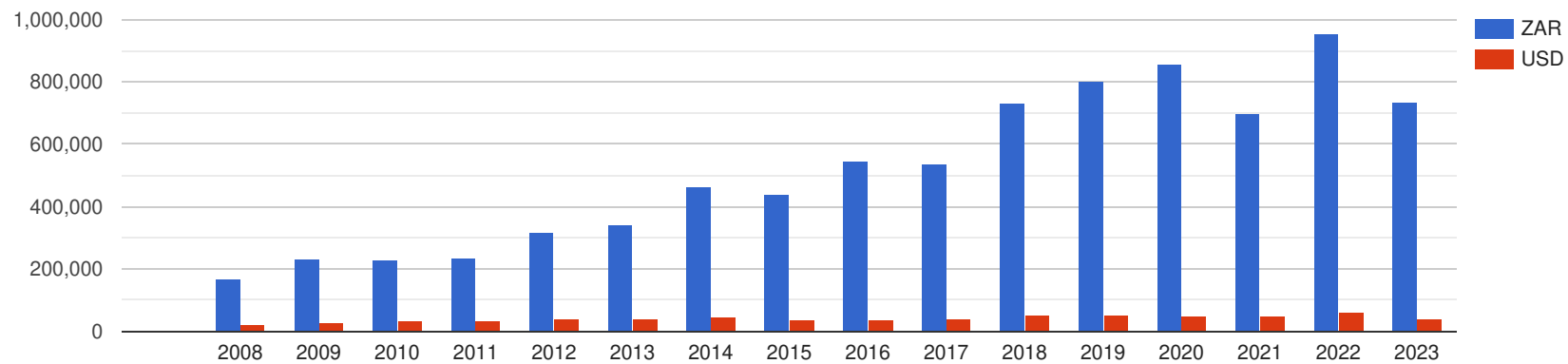
CEO Remuneration - USD
