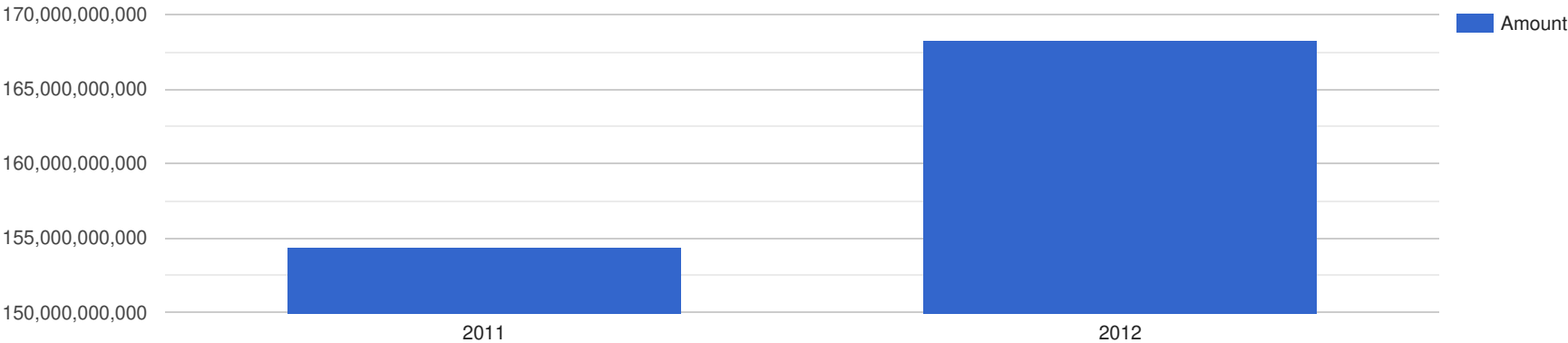

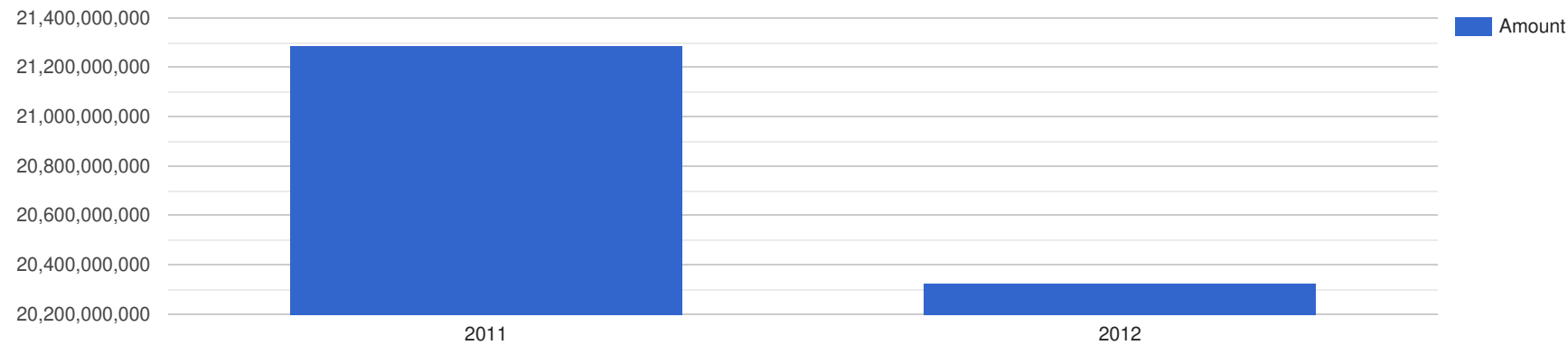

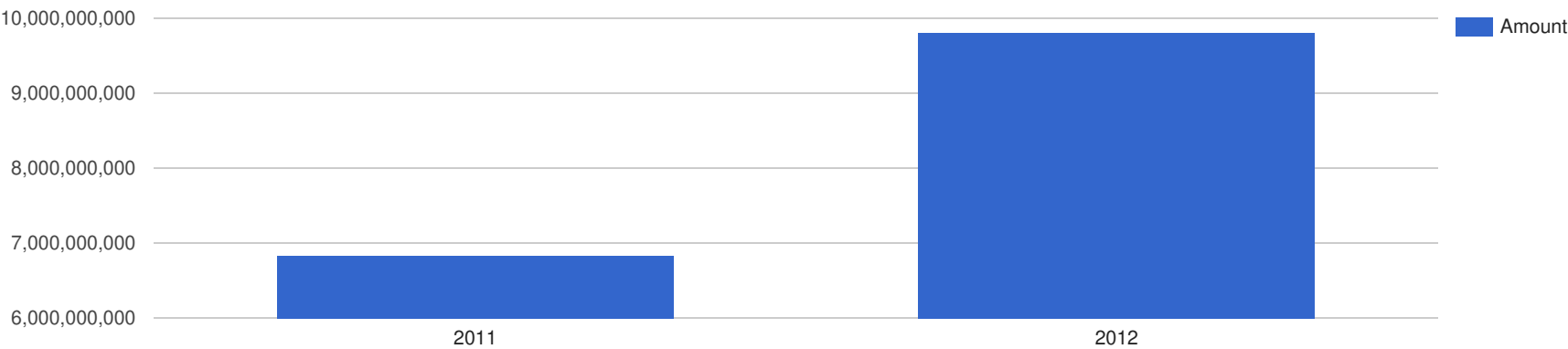
Company Revenue - ZAR



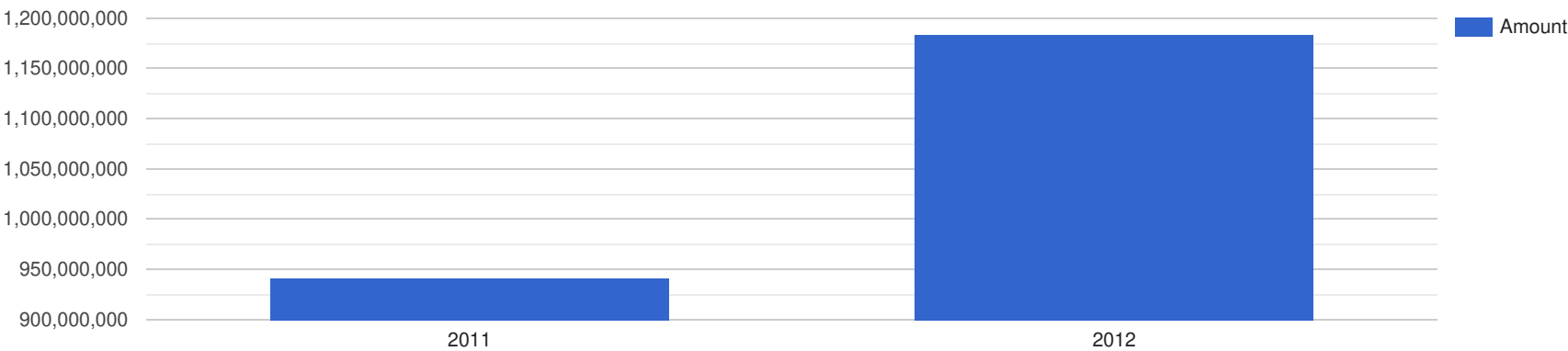
Company Revenue - USD

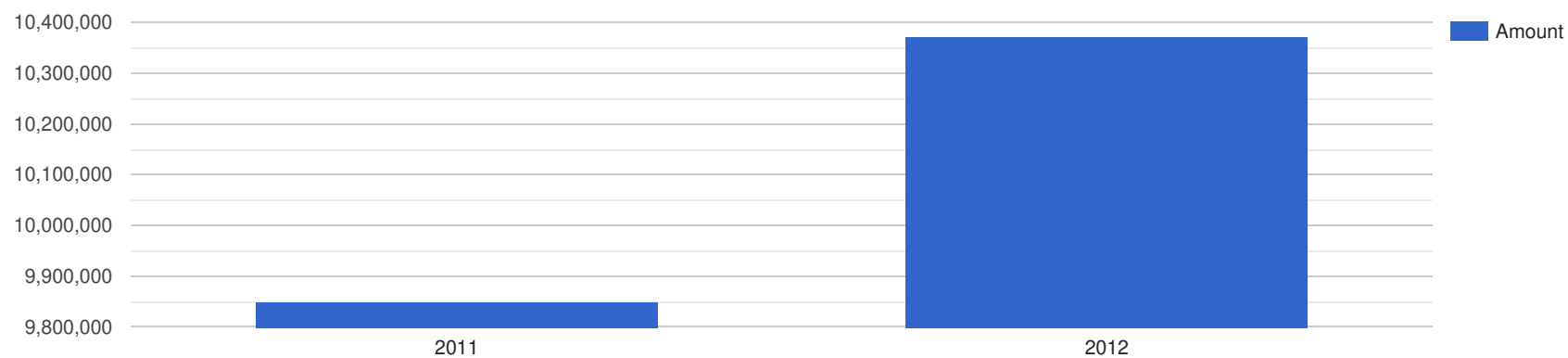

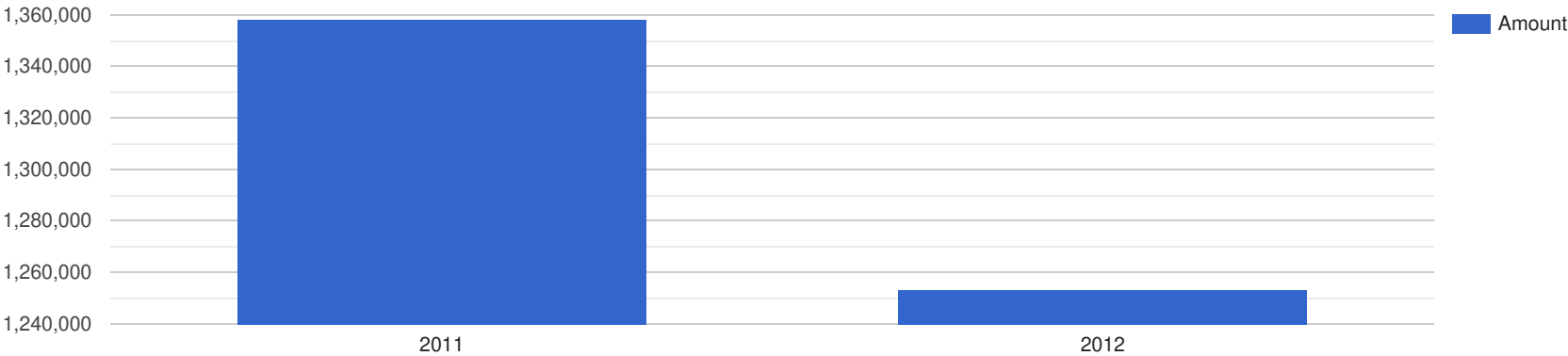

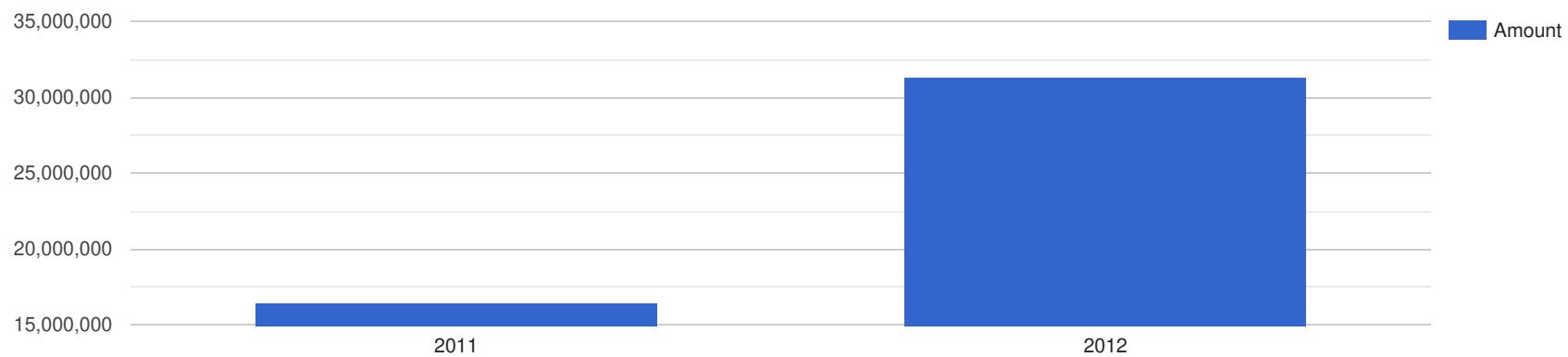
### CEO Salary - ZAR



CEO Salary - USD

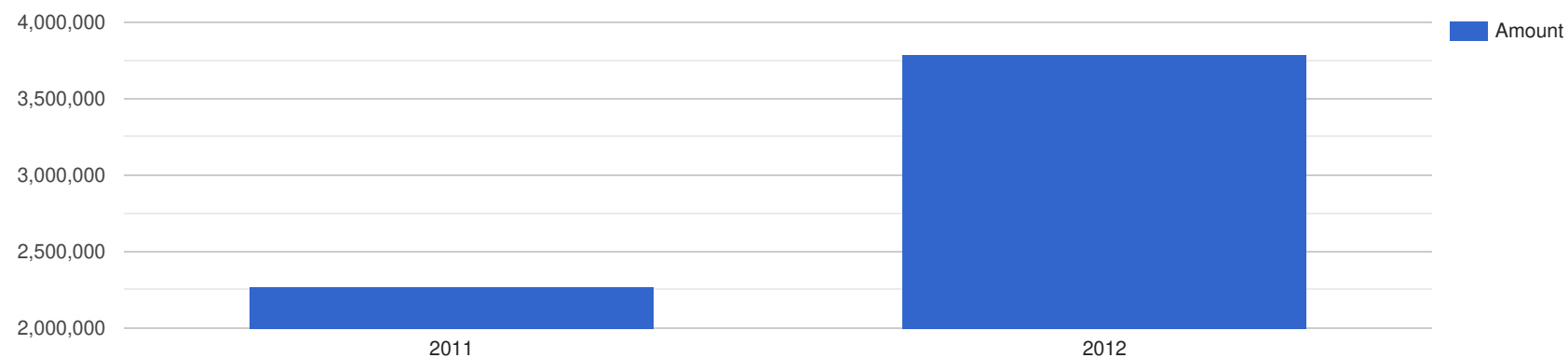


**CEO Remuneration - ZAR**

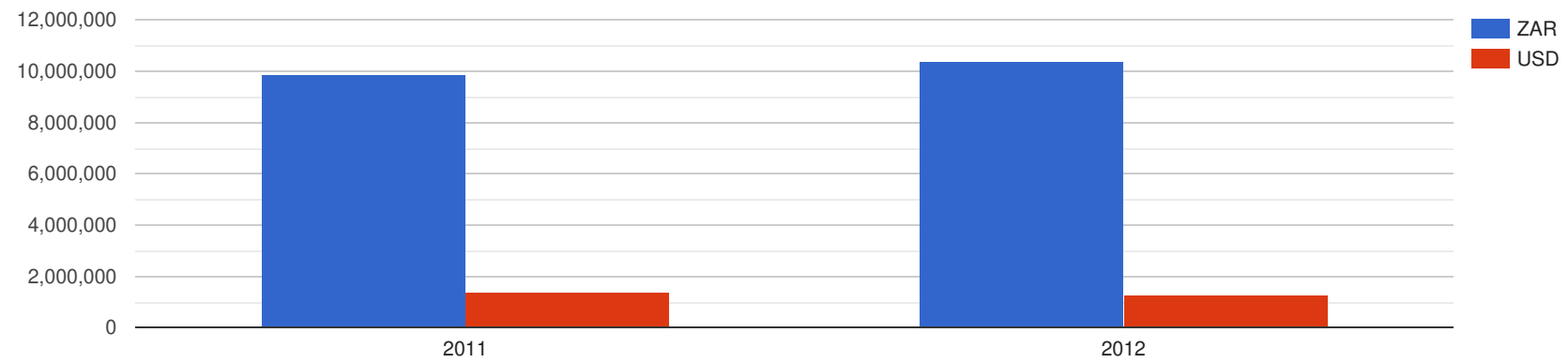




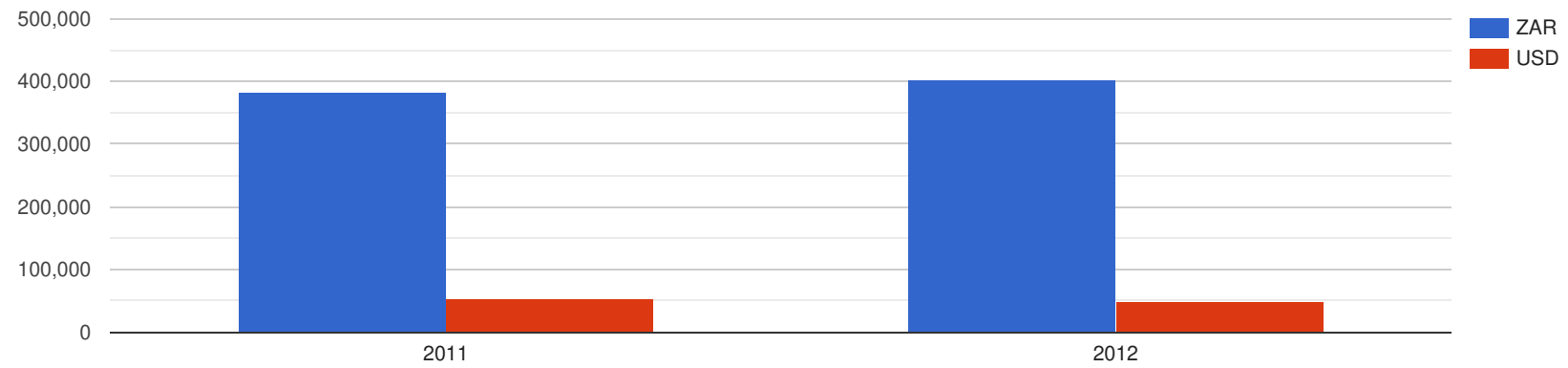
CEO Remuneration - USD
