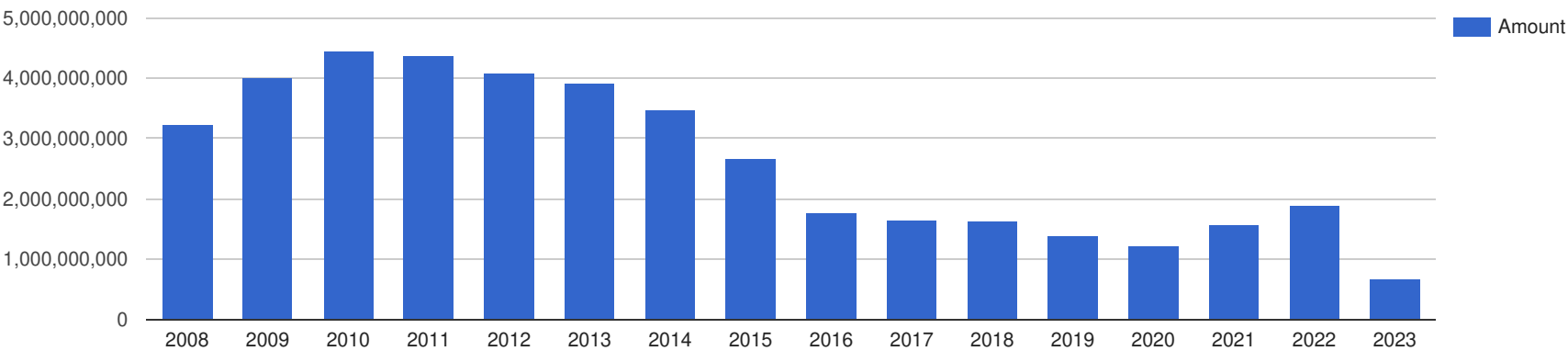

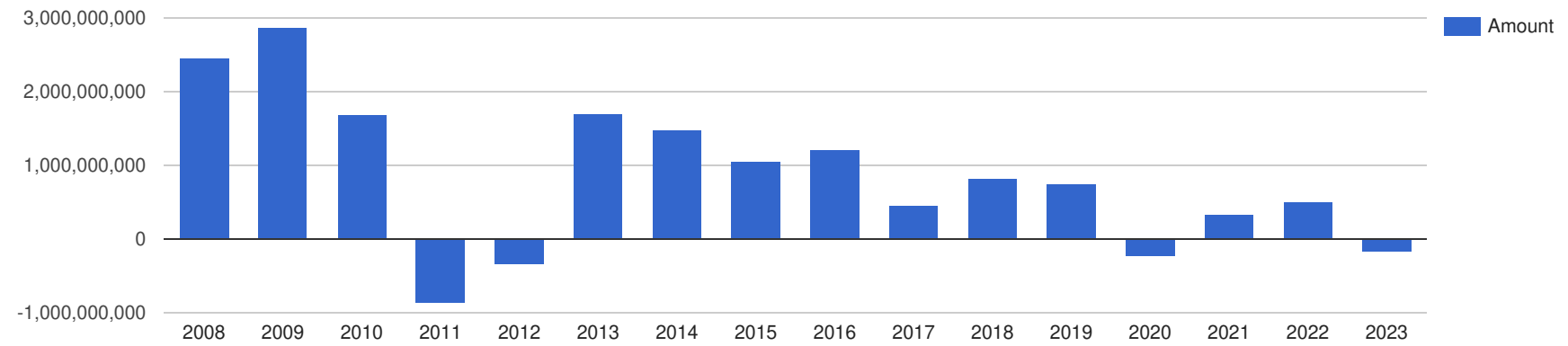

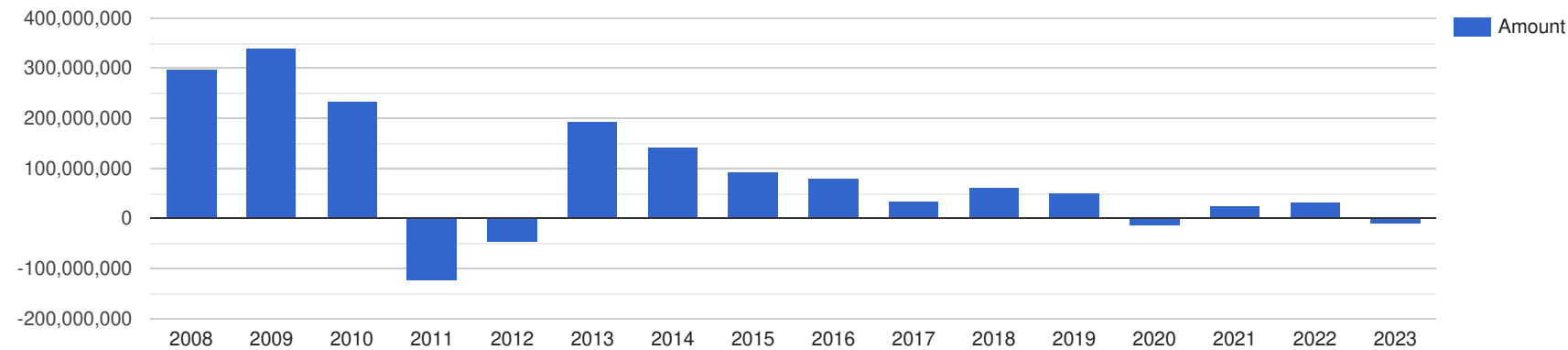


Company Revenue - USD

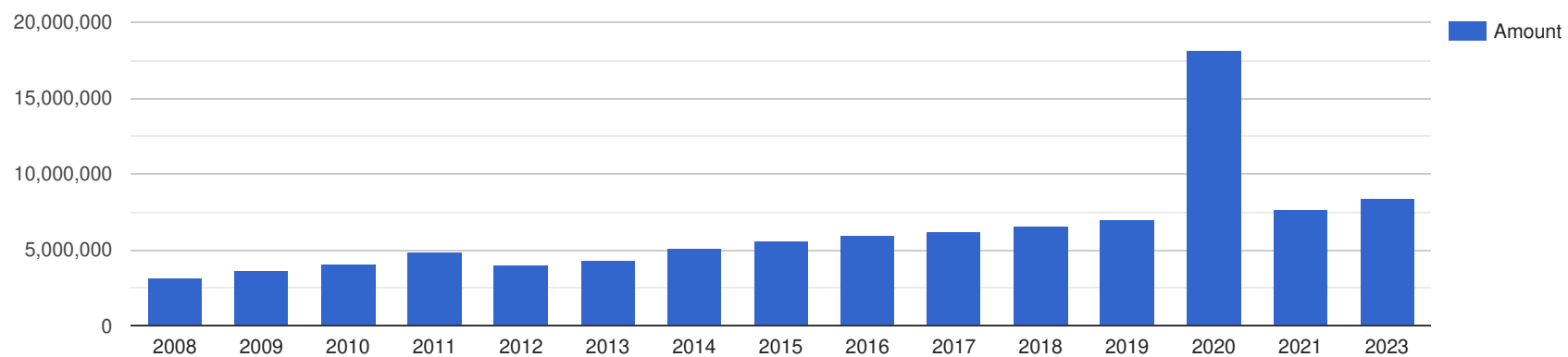

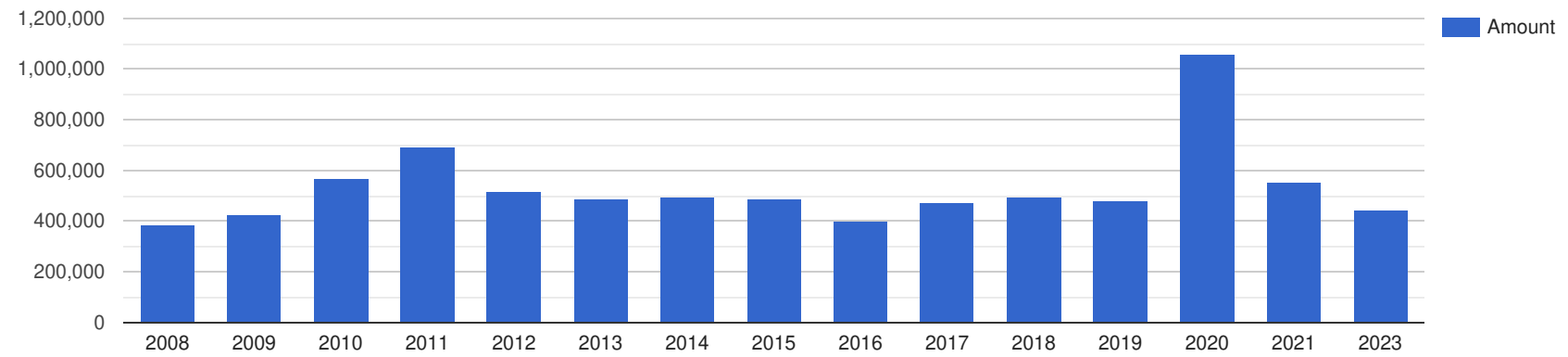

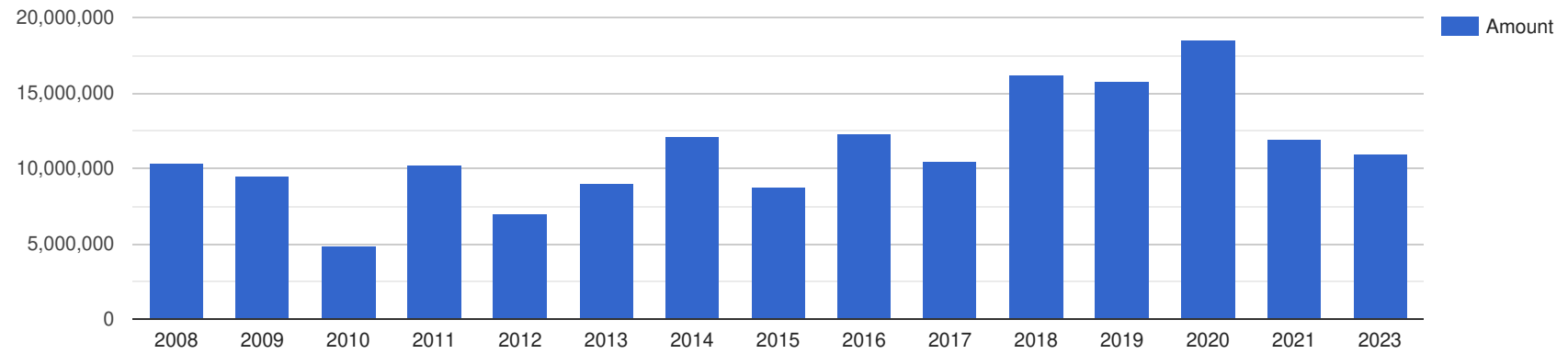
### CEO Salary - ZAR



## CEO Salary - USD

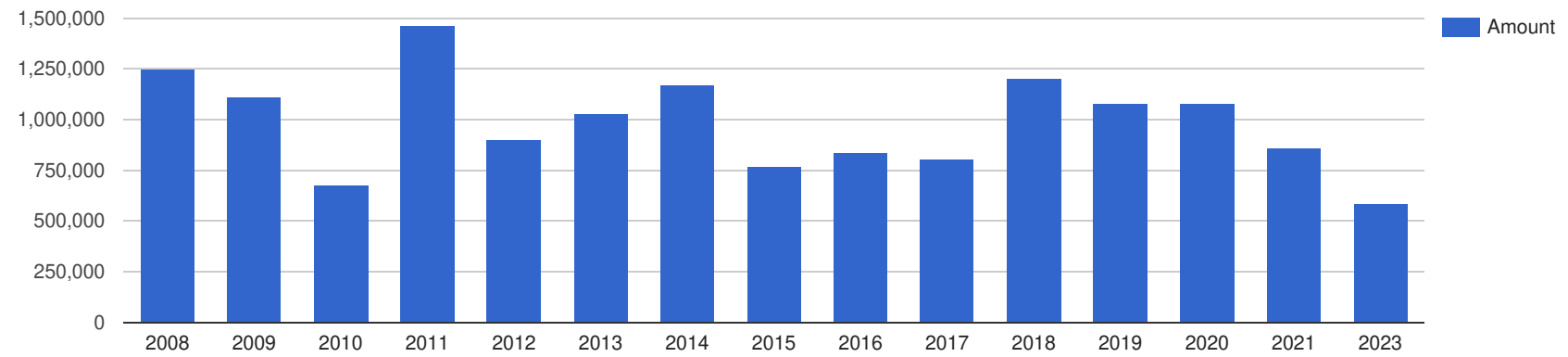


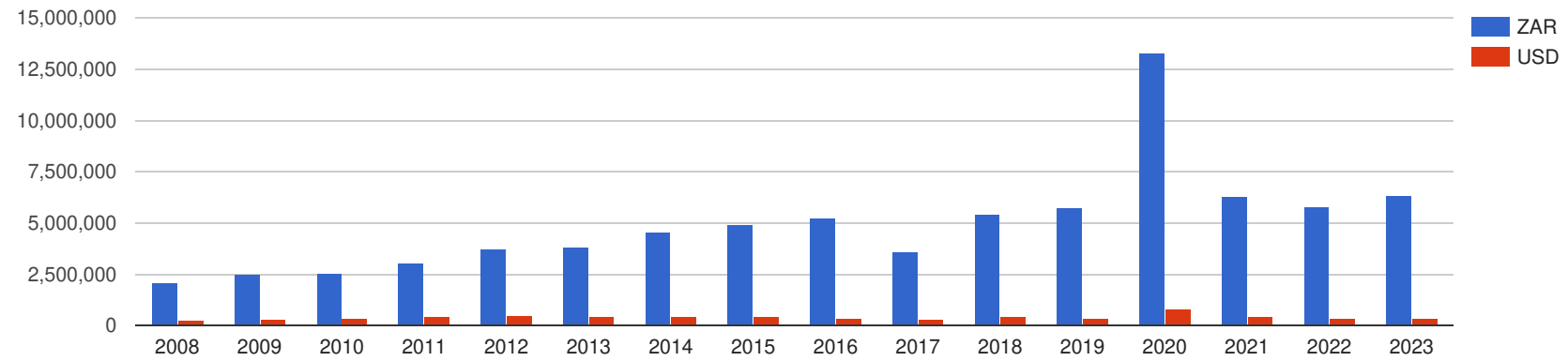

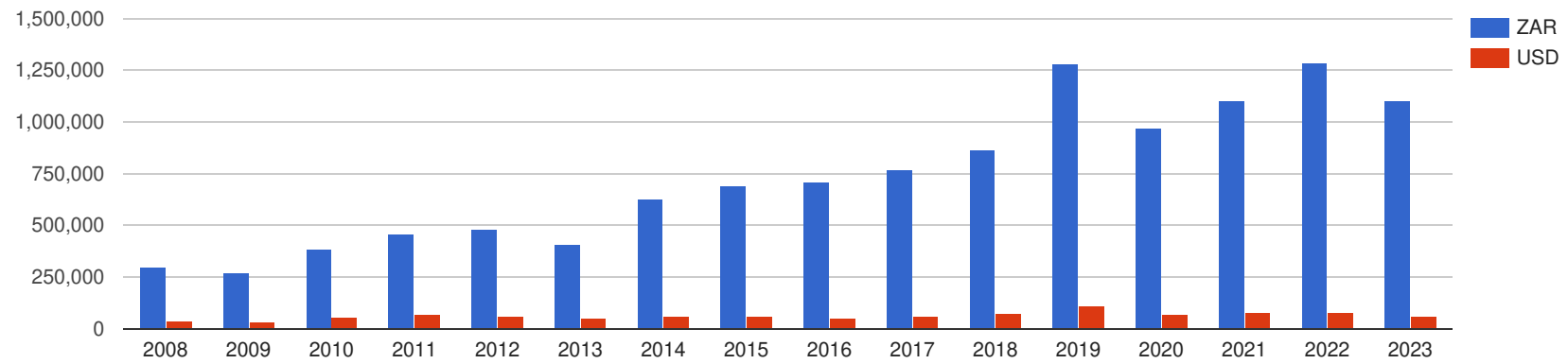
